1. Participating products will only be considered for rebate calculations if reported via electronic data exchange (EDI) or point of sales (POS) from an authorized Dow AgroSciences or Mycogen Seeds dealer and invoiced between September 1, 2013 and August 31, 2014.
2. Purchases qualify only if they are applied or planted in the states or counties listed above. Purchases cannot qualify for more than one Dow AgroSciences rebate program.
3. Rebate payment will only be made on purchases that are used on the grower's owned or rented acres.
4. Rebate payment will only be made to the party named on the invoice.
5. Dow AgroSciences reserves the right to audit grower purchases and use of Dow AgroSciences products on their owned or rented acres.
6. All rebate information provided by Dow AgroSciences regarding individual program earnings is a good faith estimate of total earnings potential. Actual total program earnings and payments will be calculated by Dow AgroSciences at its sole discretion.
7. For seed containing insect-protection traits, grower must be in full compliance with all the IRM requirements relating to the product. Acres NOT in compliance will not qualify for rebate.
8. No purchases of seed containing licensed traits will qualify under this program unless the grower has signed a valid Technology Use Agreement with the technology provider prior to planting.
